2. I am submitting this Affidavit to Johnstown Christian School in accordance with the provisions of Section 6344.2(B.1) of the Pennsylvania Child Protective Services Law, 23 Pa.C.S.A. Section 6301 et seq.
3. I understand that Johnstown Christian School will be relying on my statements in this Affidavit for the purpose of determining whether I may serve as an unpaid volunteer for Johnstown Christian School.
4. I have been a Pennsylvania resident during the entirety of the ten-year period immediately preceding today's date.
5. I am not disqualified from service pursuant to Section 6344(C) of the Pennsylvania Child Protective Services Law, in that:

    - ix. Section 3125 (relating to aggravated indecent assault);
    - x. Section 3126 (relating to indecent assault);
    - xi. Section 3127 (relating to indecent exposure);
    - xii. Section 4302 (relating to incest);
    - xiii. Section 4303 (relating to concealing death of a child);
    - xiv. Section 4304 (relating to endangering welfare of children);
    - xv. Section 4305 (relating to dealing in infant children);
    - xvi. A felony under section 5902(b) (relating to prostitution and related offenses);
    - xvii. Section 5903 (c) or (d) (relating to obscene and other sexual materials and performances);
    - xviii. Section 6301 (relating to corruption of minors);
    - xix. Section 6312 (relating to sexual abuse of children); or
    - xx. the attempt, solicitation or conspiracy to commit any of the foregoing criminal offenses.
