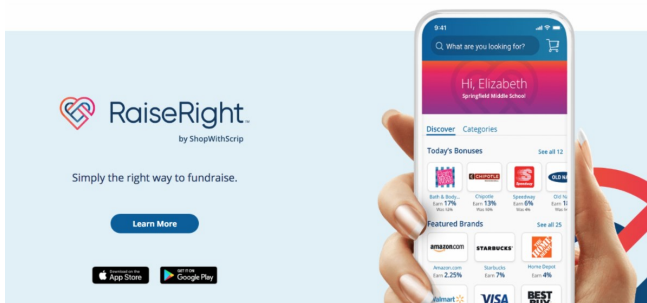


SCRIP



Scrip is another term for gift cards. Retailers provide a percentage of your purchase to the school as a donation. If you live near the school, gift cards can be purchased and picked up in the school office or sent home with a student. If you are out of town, you can set up an online account and use e-Cards (electronic cards). Simply download the free RaiseRight app. You will need to call the school for the ID to get started.
